FIRST Purpose of the Contract.

## THIRD.- Duration.

account provided by Okane Construction & Design, S.L.

This contract takes effect from the date the client pays 100% of the amount for the formalization of the FAST PROPERTIES ADVISORY service.

FOURTH.- Responsibility.

Okane Construction & DesignS.L. will be responsible for fulfilling the entrusted advisory as long as the

payments made by the client cover the total agreed price for the service.

FIFTH.- Applicable Law and Competent Jurisdiction

This Contract will be governed and interpreted in accordance with the Laws of Spain. For any issues or

controversies that may arise from the interpretation of this contract, both parties agree to submit to the jurisdiction of the Judges and Courts of Ibiza, expressly waiving any other jurisdiction that may

correspond to them.

SIXTH.- Confidentiality and Personal Data

Both parties are obliged to maintain absolute confidentiality regarding the information and documenta-

tion that both parties mutually provide or have access to during the provision of the Service. Both parties commit not to disclose or indirectly use the information and knowledge derived from the contractual relationship agreed between the parties in other services that are not the object of this Contract. is terminated, the Provider will destroy all information stored in any medium or reproduced by any

process.

Both parties commit to maintaining the utmost secrecy regarding personal data they access in the performance of this contract and to observe all legal provisions contained in the Organic Law 15/1999 on

the Protection of Personal Data. In particular, the Provider commits not to apply or use the personal data

processed or accessed during the provision of the Service for purposes other than those specified in this Contract, nor to transfer them, not even for their conservation, to other persons. The Provider will

apply to the data processed on behalf of the Client the security measures established in Royal Decree

994/1999, Security Regulations, according to the type of data processed. Once the service is finished, the Provider must return the data to the Client in the same medium in which it was sent and not keep

any copy of it. Both parties will be liable to each other for any damages that may arise from the breach

of this obligation.
